

EVA HAMMOND SCHOLARSHIP TRUST AWARD

Eligibility

Any past student who is about to commence a course of tertiary education including students who are within 6 months of leaving the school for that purpose.

Purpose of Award

To give financial assistance to past students of the School in respect of any recognised course of tertiary education but with priority given to University education wherever possible. The assistance should benefit students on a basis of financial need and such other deserving qualities as the Board of Trustees may elect.

Payment of Bursary

The Bursary shall be paid out to the student after the student presents evidence of enrolment in a course of study at a tertiary institution.

Selection Committee

- a) Chairperson of the Thames High School Board of Trustees and Chairperson of the Thames High School Finance Committee and the Principal PLUS a person appointed by members of Eva Mary Hammond's family, namely Howard William Ian Hammond of Dargaville, Solicitor, Patricia Mary Brimblecombe of Auckland, Company Director, and Marion Winifred Hammond of Auckland, School Teacher or the survivors or survivor of them or any other member or members of the Donor's family appointed by the survivor during his or her lifetime, or failing such appointment, the Thames-Coromandel District Council may appoint a person to be a member of the trust if a member of the family is not available.
- b) A person with a university degree appointed by the Board of Trustees for the Thames High School but independent of the School.

Applications

- a) The closing date for applications is **Friday 25 October 2019 at 4.00pm**
- b) Written applications only are acceptable.
- c) The Principal's PA is to receive the applications.
- d) All information is confidential to the selection committee.

Selection of Applicants

The selection committee will consider the applications with a view to making its decision and notifying the successful applicant/s before the end of the school year. The committee's decision shall be final and shall not be subject to review. It shall not be obligatory for the committee to award the Bursary if it is considered that no applicants meet the required standard.

Progress Reports

The Trustees of the Hammond Estate wish to maintain an interest in the progress of students who are awarded Bursaries. The recipient of the award should inform the Trustees of the Hammond Estate of their progress at the end of the year.

Awarding Guidelines

The Bursary Award/or awards will be at the discretion of the trustees.

The Trustee appointees are Ms Marion Hammond appointed by the family trustees and Ms Jane Hunter, Solicitor of Thames, appointed by the Thames High School Board of Trustees.
